金砖国家合作机制成立以来,五国经济发展速度明显高于西方发达经济体,五国经济总量 增长179%、占全球比重从12%上升到23%,贸易总额增长94%、占全球比重从11%上升到16%, 对外投资比重从7%上升到12%。2016年,五国间贸易总额近3000亿美元,超过全球80%的国 家的GDP。在过去十年中,金砖国家推动世界经济增长,完善全球经济治理,加强发展中国家 间合作、加强新兴市场国家和发展中国家在国际经济金融事务中的代表性和话语权,携手应对 国际金融危机冲击,为促进全球经济金融稳定做出重要贡献。当前,金砖合作机制已成为国际 上具有重要影响的机制。

现尤为出色,华为、中兴、格力、TCL、美的等一批有实力的民营企业已经走在全国的前列, 率先涉足金砖市场。目前,其他金砖国家中,印度的经济发展势头良好,南非、巴西、俄罗斯 也呈现出积极向上的发展态势,可以说,未来的前景较好,广东民营企业将会有更大的空间去 开拓。

Remarks on BRICS Think Tank Int'l Symposium & Wanshou Forum 2018

Distinguished guests, ladies and gentlemen, friends:

Good morning!

It is a great pleasure to be invited to the 2018 BRICS Think Tank Symposium, which holds in Guangdong Province for the second time. During the symposium, experts and scholars from home and abroad, diplomats from Embassy in China, representatives from business and press circle, gather in Guangdong to exchange and express their insights, and provide suggestions and ideas for the further development of BRICS. On behalf of the Foreign Affairs Office of People's Government of Guangdong Province, I would like to extend my warm congratulations to the smooth opening of BRICS Think Tank Int'l Symposium & Wanshou Forum 2018, and also would like to extend our sincere welcome to all the guests.

Since the establishment of the BRICS cooperation mechanism, the economic growth rate of the BRICS is obviously higher than western developed economies. Our combined GDP has grown by 179%, and its share in global economy has grown to 23%, up from 12%. The total trade volume has increased 94 %, taking up 16% in global total from 11%. As for the proportion of foreign investment has risen from 7 % to 12 %. In 2016, trade between the five countries totaled nearly \$ 300 billion, surpassing 80 % of the world's GDP. Over the past decade, BRICS promoted world economic growth, improved global economic governance, enhanced cooperation among developing countries, reinforced the representation and voice of emerging market countries and developing countries in international economic and financial affairs, and jointly tackled the impact of the international financial crisis, and made important contributions to promoting global economic and financial stability. At present, BRICS cooperation mechanism has become an important mechanism in the world.

President Xi Jinping, in his keynote speech at the opening ceremony on BRICS Business Forum, summed up the profound connotation of BRICS spirit in following words "treating each other as equals and seeking common ground while shelving differences; taking a results-oriented, innovative approach

to make our cooperation benefit all; developing ourselves to help others with the well-being of the world in our mind". BRICS cooperation has gone through 10 years with the engraving of China's strength and the sublimation of China's wisdom, BRICS spirit owns a bright future. China is not only an active advocate of BRICS cooperation, but also a strong promoter of close cooperation between BRICS and developing countries. Guangdong province, as one of the earliest and most open provinces in China, has been playing an integral role in foreign trade and investment. It can be said that in the past decade since the establishment of the BRICS cooperation mechanism, the level of trade between Guangdong and other BRICS countries has also increased significantly. In 2017, the total value of imports and exports goods trading reached \$ 1006.49 billion, an increase of 5.4 %; Of this total, exports took up \$ 622.78 billion rising at a rate of 4%, and imports rose \$ 383.71 billion, achieving an increase of 7.6%. In 2016, total imports and exports from Guangdong to the BRICS countries exceeded \$ 50 billion, at an increase of 292 percentage point compared with \$ 12.734 billion in 2006. It is worth mentioning that in terms of trade and economic cooperation with Russia, India, Brazil and South Africa, Guangdong's private enterprises do particularly good. A number of powerful private enterprises, such as Huawei, ZTE, Gree, TCL, Midea, etc, have been at the forefront of the country, taking the lead in the BRICS market. At present, among other BRICS countries, the economic development momentum of India is quite good. South Africa, Brazil, and Russia also present a positive trend of development. It can be said that the future prospect is better, and the private enterprises in Guangdong will get more space to develop.

Currently, the global economic outlook remains complex, and enterprises face more challenges in foreign trade and investment. With the rise of International Trade Protectionism, some countries raise scrutiny of foreign capital. While due to regime change, policy instability and social turbulence, political risks are high for companies "going global" in parts of developing countries. In such environment, how to further give play to complementary advantages of BRICS, how to improve cooperation and innovate BRICS cooperation mechanism, these questions need go into deep studies, accurate judgments and measures to promote BRICS coordinated development. Guangdong and other BRICS countries share similar development stage, thus there are much experiences we can learn from each other. The stronger industrial complementarity we have, the greater cooperation and potential we own. We can say, it has far-reaching significance for Guangdong Province, even for China, to strengthen our exchange and cooperation with other BRICS countries, and to achieve common development.

With continuous deepening of cooperation with the BRICS countries, Guangdong enterprises are also in a more positive attitude to implement the achievement of BRICS cooperation. The founding of the CCBTC is a pragmatic move of us to push forward BRICS think-tank cooperation to a higher level.
